Wauwatosa Police and Fire Commission Chairperson Long:

Due to planned retirements of Community Specialists in June of 2025 and January of 2026, a selection process was completed in Spring of 2025. This specific assignment is designated in the labor contract as an "appointment" as opposed to a "promotion." This process is not outlined in the labor contract, but gives the Administration authority to create a "procedure" to appoint employees. The process, consistent with prior Community Specialist processes, was comprised of the following rated steps:

- 1. Resume, cover letter, written response to essay questions
- 2. Supervisor evaluation
- 3. Interview panel

After completion of the process, all successful candidates were placed into an eligibility pool which is valid until 10/7/26. The next candidate that is eligible for appointment is Patrol Officer Dexter Schleis. Officer Schleis is scheduled for appointment to this new position on 10/5/25.

Wauwatosa Police and Fire Commission Chairperson Long:

Due to retirements in the Investigative Division, a Detective promotion process was completed in July of 2024. This process is governed by the collective bargaining agreement with the Wauwatosa Peace Officers' Association (WPOA). The promotion process has three weighted components:

- 1. Written test (40% of total score)
- 2. WPOA seniority (10% of total score)
- 3. Supervisory evaluation (50% of total score)

After completion of the promotion process, all candidates are then ranked and the final list is valid until February 2026. The next candidate that is eligible for promotion is Patrol Specialist Daniel Mitchell. Specialist Mitchell will be promoted on October 5, 2025.
