1. Purpose of Supplement

Pursuant to Wis. Stat. § 893.80, this supplement is filed to provide specific liquidated damages regarding the damaged sprinkler system at [REDACTED]. In the original Notice of Claim, it was noted that a professional estimate for these repairs was being obtained and that the claim would be amended once finalized.

2. Description of Additional Property Damage

As a direct result of the excavation and repair work necessitated by the City crew's damage to the water valve assembly on August 26, 2025, the residential irrigation system sustained significant damage.

3. Updated Amount of Damages Claimed

The claimant has received a professional budget estimate from Acme Systems, dated January 18, 2026, for the repairs to the irrigation system.

- **Previous Total (Water Service Line):** \$8,380.00
- **Additional Damages (Irrigation System Estimate):** \$2,200.00 – \$2,600.00
- **REVISED TOTAL CLAIMED: \$10,580.00 – \$10,980.00**

As noted in the attached estimate, the final cost of irrigation repairs will be determined on a time-and-materials basis once the system is activated in the Spring of 2026 to identify all subsurface damage caused by the City's installation of the new water line.

4. Conclusion

The claimant maintains all arguments regarding negligence, inconsistent information, and constructive compulsion as outlined in the original Notice of Claim. The City is requested to incorporate these additional damages into the pending claim for reimbursement.
