Parking Variance - M. Dika Dermatology, 6027 W Vilet Street

Dear Mr. Pinon,

M. Dika Dermatology is considering to occupy a portion of the building located at 6027 W. Vilet St. and is requesting a variance for the parking requirements in order to finalize their decision.

Wauwatosa parking code requires 6.67 spaces per 1,000 sf of medical clinic. This would require 28 parking spaces. The existing property has 10 parking spaces (9 + 1 ADA) without ability to add more.

M. Dika Dermatology is an established business that will occupy approximately 4,140 square feet of the existing building. As an established business, they have provided documentation for their current patient schedule (enclosed). Daily schedules have 3-5 patients scheduled per hour for an average appointment of 15 minutes per appointment. Total full-time staff includes one provider and one assistant. With this information, we anticipate a daily need for 7 spaces; 2 for staff and 5 to be used daily for patients.

The existing business that occupies the remainder of the building is a clothing screen printing company (Promolux) with 2 full-time staff. The parking code for Wauwatosa requires one parking space per staff for manufacturing/ production businesses.

With 2 spaces for Promolux and 7 proposed for M. Dika Dermatology, the existing 10 spaces (plus 1 for ADA) would be sufficient for both businesses and therefore we are requesting the variance be approved.
