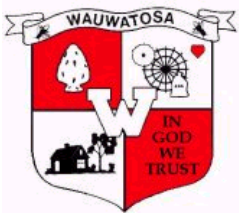

**Subject:** Monthly Sustainability Updates – **May 2025**

**A. Short-Term Priorities**

- Establish and promote sustainability incentives for developers and property owners
- Coordinate Wauwatosa participation in Grow Solar Milwaukee-Waukesha 2025 solar group buy program (if approved by Common Council) and explore additional opportunities to expand solar energy production in Wauwatosa
- Create materials highlighting sustainability features of Firefly Grove Park
- Identify next steps for fleet electrification and EV charging infrastructure planning
- Develop strategy for waste and materials management benchmarking for Wauwatosa and explore recycling or reuse options for C&D debris
- Establish and strengthen relationships with sustainability partners in Wauwatosa and in the region
