*After the Exhibits were admitted into the record, the Board heard summary arguments from the Attorney for the Assessor and the Attorneys for Children's Hospital. Counsel for the Assessor requested that based upon the*

*testimony of the Assessor that the Board add the property identified by the Assessor as omitted property from the 2023, 2024 and 2025 tax rolls in the amounts as valued by the Assessor in her testimony. The Attorneys for Children's Hospital requested that the Board not add the omitted property due to procedural and due process deficiencies that preclude the adding of the property as omitted property to the tax rolls.*

*Upon the conclusion of the testimony and arguments from counsel the Board then deliberated on the matters before them. After discussion and input from Attorney Dineen:*

*Motion by Member Fox to add the value of the omitted property for year 2025 (\$47,675,400) from Exhibit 20 to the assessment roll. Second by Member Ehley. Motion carried 3-0.*

*Motion by Member Fox to add the value of the omitted property for years 2023 (\$36,881,300) and 2024 (\$43,059,100) from Exhibit 20 to the assessment roll. Second by Member Ehley. Motion carried 3-0.*

*The Board then took up the matter of compliance with the November 7, 2025 subpoena. After discussion: Motion by Member Fox to dismiss subpoena compliance as moot. Second by Member Ehley. Motion carried 3-0.*
