Mission

The Police and Fire Commission is required by state statute 62.13 to fulfill certain functions in Wauwatosa. The Commission consists of 5 unpaid, volunteer Wauwatosa residents, appointed by the Mayor and approved by the Common Council to five-year rotating terms.

PFC Responsibilities under 62.13

1. The PFC shall appoint the chiefs of the police and fire departments who shall hold their offices during good behavior, subject to suspension or removal by the PFC for cause.
2. Establish qualifications for candidates for each department, including physical, educational, prior experience and testing.
3. Oversee the recruitment, testing and hiring process for the departments.

PFC Responsibilities under 62.13

4. Interview candidates for each department.
5. Certify a list of candidates for hire by each department, maintained by the City Clerk.
6. Approve the Chiefs' appointments of subordinates.

PFC Responsibilities under 62.13


7. Conduct disciplinary hearings on charges that may result in suspension, demotion, or termination of an employee if the employee requests a hearing. The Commission is required to address specific standards for whether just cause exists to sustain disciplinary charges.

PFC Meetings

- The PFC meets on the 3rd Wednesday of each month with the exception of July, August and December unless a special meeting (often interviews).
- Meetings are held at 4:30 pm at City Hall. Meetings are available via zoom however they are not recorded.
- Officer positions are voted on in May. Secretary is appointed by the Chair.

Police Hiring Process Timeline

The time from application opening date to hire date is 17-18 weeks, or about four and a half months.

Firefighter Hiring and Interview Information 2025

Joint process with North Shore, West Allis and St. Francis fire departments

Spring Hiring Process:

- Fall 2024 applications opened. 81 applicants
 - 49 invited to interview joint process – January, 2025
 - PFC interviewed 12 2/4/25
 - 3 interns
- 5 firefighters hired and completed JFTA
- 1 FF left after 2 months to take another position out of state.

Firefighter Hiring Process

- Fall Hiring Process
 - Joint Fire Panel Interviews – June, 2025
 - 72 applicants
 - 50 invited to interview
- PFC Interviews – June, 2025
 - 11 interviews (5 interns)
 - 3 hired for JFTA and presently on shift
 - All interns

Firefighter Interns 2025

- April Intern Process
- 46 applied (up 12 from 2024)
- PFC interviewed 21 applicants in April
- 10 offered internships
 - 3 applicants were not yet 18.
 - 6 interns hired as firefighters

Firefighter Interns 2025

July Intern Process

- 60 applicants
- 21 interviewed
- 11 offered internships
