A. Issue

Neighborhood Theater Group, LLC d/b/a Rosebud Cinema has submitted an application for a new retail Class "B" Beer and "Class C" Wine license for their establishment at 6823 W. North Avenue.

B. Background/Options

Neighborhood Theater Group, LLC previously held a retail alcohol license thru the 2022-2023 licensing year but did not renew for the 2023-2024 licensing year. They are now looking to reopen their business and are looking to obtain the appropriate retail alcohol license. A background check was conducted on the Agent, Jane Schilz, on December 14, 2023 and no violations substantially related to licensing activities were found. The Agent met all other qualifications.

C. Department Reviews

Police: No issues. **Fire:** No issues.

Health: No issues. They have been working with the Health Dept to obtain a food license.

Finance: No issues.

Building/Development: Rosebud has an existing building occupancy permit. However, if the owner or use change, Rosebud will need to apply for new occupancy, as well as inspection from Building, Fire, and Health. As it relates to zoning, nothing additional is needed unless the use changes from what was approved in their original Conditional Use permit.
