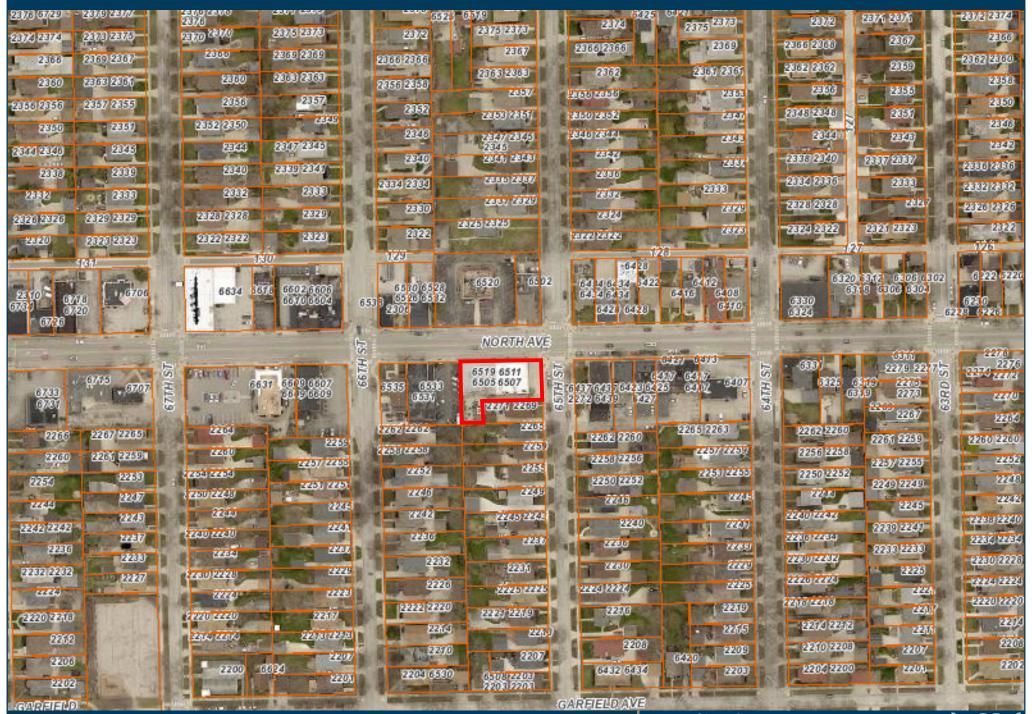

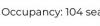


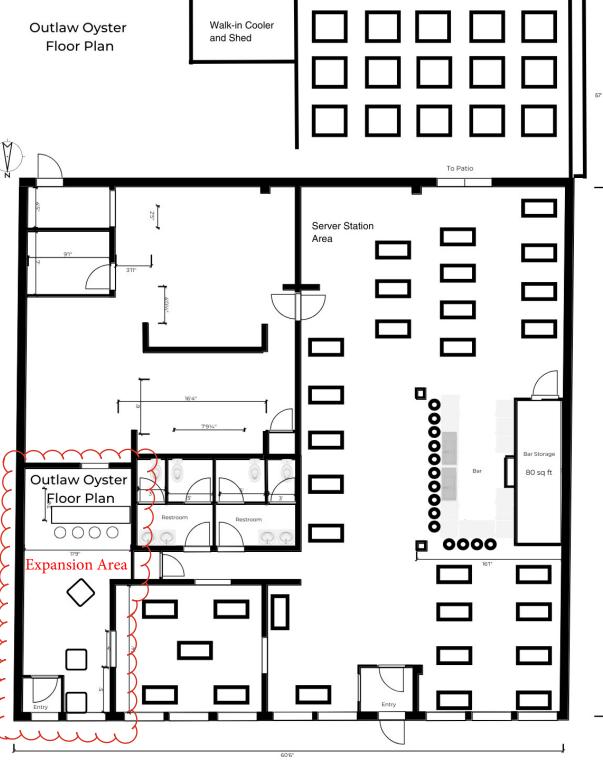

This floor reflect no COVID-related occupancy restrictions in place.

Outlaw Oyster is a seafood concept, I attached our menu to this application as well. Our hours of operation would be 11am - 12am 7 days a week. Currently we plan to operate at less than that to start but hoping to add hours as we figure out demand. We have added 7 positions for this concept, with an additional 10-30 hours from our current staff depending on volume. If we expand the hours to 7 days a week we will need to add another 4 positions at a minimum. The goal of the pop up is to test the market to eventually turn things into a full fledged concept, but this ensures us that we can do what we set out to do.

To us, we view this as a marketing opportunity to be able to offer another product, akin to a ghost kitchen, offering catering services, creating a speakeasy, or a seasonal menu. We are operating as a restaurant as the space was set out for. We are just adding some seating over into the room that did not have any seating in to maximize potential for this pop up. We project that this will add an additional \$468,000 in taxable revenue if we only operate at the limited starting hours. There is not a concept like this in Milwaukee done this way, and it will be a huge asset for the area, adding to the great city of Wauwatosa.

We love what we have been able to do as Crafty Cow, and hope solidifies us as a great community partner, and that we continue to work towards expanding jobs and opportunity here in Wauwatosa.

Pipsqueak Wine's Garden space at 6404 W. North Ave is owned by Glanahan Redbrick LLC, a LLC owned by Joe Galbraith and Nick Carnahan, the owners of 6410 W North Ave as well as 6404 W North Ave.

We are seeking Conditional Approval to use the space as a seasonal adjunct to our indoor business, which sells wine and beer for on and off premise consumption, as well as charcuterie plates and small bites.

The door to Pipsqueak Wine is south facing and opens onto a ramp which is east west. The ramp goes all the way to the southwest edge and into f the garden and will be the access point for people going back and forth between the inside and outside of Pipsqueak Wine. Pipsqueak Wine also has a north facing back door that will serve as not only the emergency exit for Pipsqueak Wine, but as a service door for staff coming in and out.

On the northeast side of the garden will be a pergola approx.. 12'x 20', it is in this pergola that we will have seating for 12 and will make up the area we where will serve customers in our garden.

Pipsqueak Wine currently is staffed by the owners, Jonathan Blechman and Heather Mitchell as well as one part time employee. We will be adding one additional part time and one full time employee as we extend our days of service for the outdoor season.

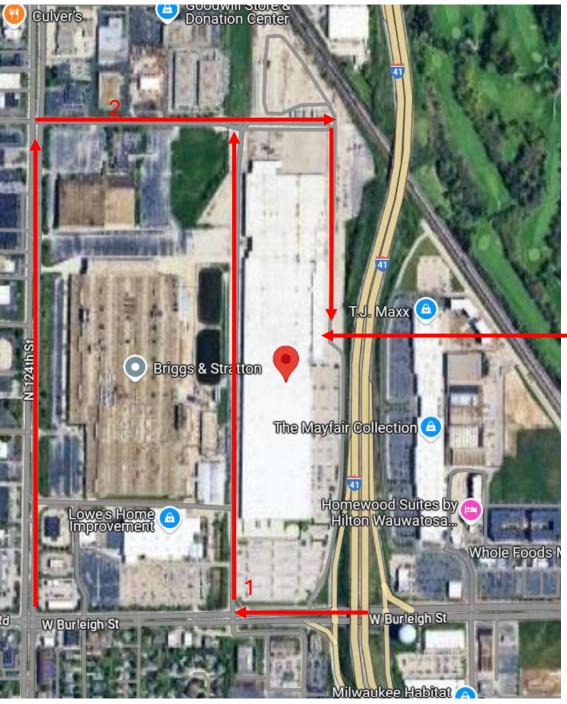

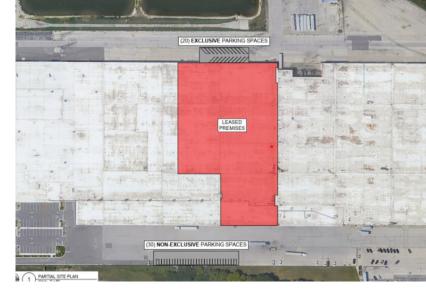


# CURRENT TEST FIT PLANS BURLEIGH WAREHOUSE

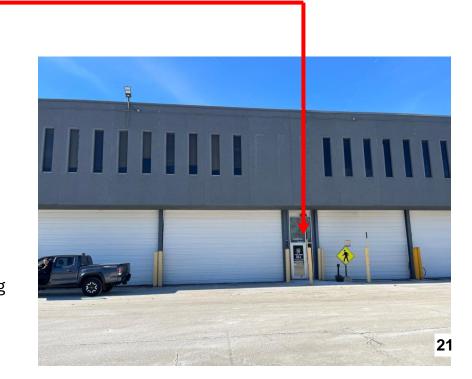

On the night of 3/3/25 I was driving east-bound in the right lane on Burleigh St towards the freeway. The right lane of the road had been closed previously for some road work, but was now open. Several cars in a row were driving in that lane and we all drove into a large square of the road that had not been repayed or properly repaired. Several of us in a row destroyed our tires on the jagged pavement at the edge of a large dip in road height. It cut straight through both my passenger tires (which were less than 30days old). I called a towing service to flatbed my car. The towing service was great, but there was damage done to my bumper clear wrap due to tow straps along with damage to my front passenger wheel from scraping on the road deformation. I paid for the following services, tow, new tires, bumper repairs, wheel repair, inspection, and alignment of my car to fix all the issues. I went back to the scene after having replaced the tires for a high expense late that same night. I called the non-emergency number for the Wauwatosa Police Department. Officers arrived and promptly put all the work cones back out in the road to block it off, but not before another person drove over this spot and destroyed their tires too. The Officers blocked the road and stated that they would contact the DPW in the morning to have it repaired ASAP. This should have NEVER been left this way and was a dangerous hazard to drivers. It seems that the road was repaired the following day.
