A. Issue

Public Works crews are having difficulty navigating certain alley intersections.

B. Background/Options

This item is before the Transportation Affairs Committee following the completion on a 90-day trail. The street abutting 8121 W. Portland currently has 2-hour parking from 9:00AM to 4:00 PM except Saturdays, Sundays, and holidays. The street abutting 8124 and 8130 W. Gridley Avenue also currently has 2-hour parking from 9:00AM to 4:00 PM except Saturdays, Sundays, and holidays. There are no restrictions on parking at 1122 N. Kavanaugh Place. Public Works crews are having difficulty navigating alley intersections at these addresses when vehicles are parked across from the alleys.

Following discussion with DPW, staff recommends no parking on the south side of Portland Avenue from 114' west of Glenview Avenue to 140-feet west of Glenview Avenue, on the north side of Gridley Avenue from 192' west of Glenview Avenue to 236-feet west of Glenview Avenue, and on the east side of Kavanaugh Place from 148-feet north of Gridley Avenue to 171-feet north of Gridley Avenue. These limits match the 90-day trial.

Consideration of request from Engineering Division for a 60-day trial of a parking prohibitions on the east side of 60 th Street from Wisconsin Avenue to the South City Limit

A. Issue

On-street parking during events at American Family Field impact travel and access along 60th Street

B. Background/Options

Parking is currently prohibited along the west side of 60th Street from Blue Mound Road to 142-feet north thereof (along Blue Mound Automotive), and has no signed restrictions north of this point to Wisconsin Avenue. No signed restrictions exist along the east side of 60th Street from the South City Line (north of O'Reilly Auto Parts) to Wisconsin Avenue. Residents have requested that parking be prohibited along one side of 60th Street.

60th Street is 24-feet wide. Nearby business(es) offer shuttle services to/from events at American Family Field. When this happens, 60th Street is parked on both sides of the street, resulting in a narrow 8-foot wide travel lane for two-way traffic. Access to residential driveways is also greatly diminished.

Staff recommends initiating a 60-day trial for parking prohibitions along the east side of 60th Street from Wisconsin Avenue to the South City Limit (see map on following page). The east side is recommended over the west side to aid in lines of sight and turning maneuvers to/from corners at Michigan Street. The 60-day period matches a similar request that was made and ultimately passed Council for parking prohibitions on the south side of Michigan Street in Year 2024. A map showing nearby existing parking prohibitions and the proposed trial of parking prohibitions is included with this staff report on the following page.

Location of Proposed 60-Day Trial of Parking Prohibitions 60th Street, Wisconsin Avenue to South City Limit







City of Wauwatosa Receives \$1 Million in Federal Grants to Improve Walnut Road Railroad Crossing

(January 16, 2025) Wauwatosa will receive \$1 million in grant funds from the U.S. Department of Transportation's Federal Railroad Administration (FRA) to improve the crossing at Walnut Road. The most significant outcome of the project would be the elimination of the at-grade crossing and total elimination of any train-vehicle conflict.
