**NOTICE OF CLAIM PURSUANT TO SECTION 893.80(1d)(b), WIS. STATS.  
FILED BY JADA CARTER**

Please take notice that we represent Jada Carter who resides at 3353 N. Vel R. Phillips Avenue, Milwaukee, Wisconsin 53212 and hereby give notice of claim concerning the injuries sustained by Jada Carter on April 30, 2025 when the vehicle she was operating southbound on Swan Boulevard was struck by a City of Wauwatosa DPW truck, negligently operated by Patrick Weber, as the DPW truck was attempting to turn onto Swan Boulevard from Beverly Place.
