1. Election of Officers

Per the CDA's by-laws, the election of new officers occurs when a Chair or Vice-Chair vacates their position. As Mark Hammond resigned his CDA position, the CDA needs to elect a new Chair. Alderperson Philips nominated Joel Tilleson to be Chair.

2. Update of Community Development Block Grant Application for 2025 24-1318 funding

The City's 2025 CDBG application process is underway and staff submitted a request for \$450,000 on behalf of the CDA for affordable housing activities. As the Housing Authority, the CDA oversees the Housing Rehabilitation Program and can approve funds for affordable housing projects; as an administrative and procedural requirement for the CDBG program, the attached application is submitted as part of the City's annual funding approval process.

3. Approval for staff to investigate and apply for a WEDC Small Business <u>24-1316</u> Development Grant

The Wisconsin Economic Development Corporation (WEDC) just released a new Small Business Development Grant program that will award eligible entities (CDA is one) up to \$250,000 to provide direct financial assistance to businesses, new or existing, with 25 or fewer employees (promo flyer attached). With the CDA's support, staff will submit an application for funding to support and enhance the CDA's existing small business forgivable loan programs.

4. Discussion of offer to purchase from Luther Group Acquisition, LLC for 1600 N 113th Street

<u>24-1317</u>

Staff provided an overview of recent the CDA's discussions concerning this site. The CDA heard two redevelopment proposals, one in May from Luther Group proposing a spec light manufacturing building and another in June from Chris Trudeau proposing Tosa Golf. Luther Group submitted an initial Offer to Purchase at the June meeting as well. Following a closed session discussion, the CDA discussed both proposals and chose to continue negotiations with Luther Group for reasons including an experienced developer with a track record of completing manufacturing/industrial projects, economic impact and jobs, and financial ability/experience to complete the project. In addition, the use aligns with the Redevelopment District No. 1 project plan approved by the CDA and subsequent rezoning of the parcel to accommodate the use. Comments:

- Ald. Makhlouf requested the CDA deny the Luther Group's offer, had concerns about traffic, purchase price being too low, and delays with other projects in the City; a new RFP should be issued.
- Jason Luther, 780 Elm Grove Rd, Elm Grove noted that with respect to the BMO site development, their partner left, they are still operating the site and are seeking redevelopment opportunities. On this CDA parcel, he stated they responded to the CDA's initial RFP. A traffic study would be done and the development would add value for the City.
- Chair Tilleson stated concerns about Luther Group having other delayed projects and the impact this has on getting an additional development completed.

The Authority moved to go into closed session *pursuant to Sec. 19.85(1)(e)*, Wis. Stats., for the purpose of deliberating or negotiating the purchasing of public properties, the investing of public funds, or conducting other specified public business, whenever competitive or bargaining reasons require closed session.
